## ADULT-USE LABELING AND PACKAGING

Adult-use marijuana or marijuana products

- 1. May not be a. packaged or labeled in a false or misleading manner, b.resemble the form of a human, animal, insect, fruit, toy or cartoon; c. use names that resemble or imitate food or drink brands marketed to children.
- 2. Must be labeled with:
  - a. The marijuana establishment license number;
  - b. The amount, strain, and batch number of the marijuana or marijuana product;
  - c. The form of the marijuana or marijuana product;
  - d. As applicable, the weight of the marijuana or marijuana product;
  - e. Total THC, Total CBD, and any other claimed cannabinoid.
  - f. The following statement: "ARIZONA DEPARTMENT OF HEALTH SERVICES' WARNING: Marijuana use can be addictive and can impair an individual's ability to drive a motor vehicle or operate heavy machinery. Marijuana smoke contains carcinogens and can lead to an increased risk for cancer, tachycardia, hypertension, heart attack, and lung infection. KEEP OUT OF REACH OF CHILDREN";
  - g. If not cultivated by the marijuana establishment, whether the marijuana was obtained from another marijuana establishment or a dispensary;
  - h. If not infused or prepared for sale by the marijuana establishment, whether the marijuana product was obtained from another marijuana establishment or a dispensary;
  - i. For a marijuana product, the ingredients in order of abundance; and
  - j. The date of manufacture, harvest, or sale.
- 3. Must be placed in child-resistant packaging on exit from the marijuana establishment.

## MEDICAL LABELING AND PACKAGING

Medical marijuana provided by the dispensary to a qualifying patient or a designated caregiver must be labeled with:

- 1. The dispensary's registry identification number
- 2. The amount, strain, and batch number of medical marijuana
- 3. The following statement: "ARIZONA DEPARTMENT OF HEALTH SERVICES' WARNING: Marijuana use can be addictive and can impair an individual's ability to drive a motor vehicle or operate heavy machinery. Marijuana smoke contains carcinogens and can lead to an increased risk for cancer, tachycardia, hypertension, heart attack, and lung infection. KEEP OUT OF REACH OF CHILDREN"

- 4. If not cultivated by the dispensary, whether the medical marijuana was obtained from a qualifying patient, designated caregiver, or another dispensary
- 5. The date of manufacture, harvest, or sale
- 6. A list of all chemical additives, including non-organic pesticides herbicides, and fertilizers used in cultivation and production
- 7. The registry identification number of the qualifying patient
- 8. For edibles, the total weight of the edible food product.
