

2022 CALIFORNIA PACKAGING AND LABELING REQUIREMENTS FOR "CANNABIS"

Effective January 1, 2022 to December 31, 2022

Note: These requirements are only for **non-manufactured cannabis** such as flower, leaf, kief, shake, and non-infused pre-rolls. Do not use them for manufactured "cannabis products".

PACKAGING

All cannabis must be packaged according to regulatory standards before release to a distributor, except that a distributor may prepare and package pre-rolls, and label cannabinoid content after testing. Packaging for cannabis must protect the product from contamination and must be 1. tamper-evident, 2. resealable, and 3. child-resistant (single use). Cannabis packaging must not be made attractive to children or imitate non-cannabis food products or products typically marketed to children. Packaging (but not labeling) requirements can be met using any one of multiple layers.

LABELING:

Primary Panel: 1. Product identity (generic or common name); 2. Net weight in both metric and U.S. customary units; and 3. Universal Symbol at least ½ inch square and printed in black on a contrasting background. If the product is packaged so that the immediate container holding the cannabis good can be separated from the outer packaging (such as a jar inside a box), the immediate container must be labeled with the universal symbol.

Informational Panel: 1. The UID; 2. The licensed name of the cultivator or packager, and phone number or website; 3. Month, day and year of packaging; 4. The following warning, word for word, all in caps and in bold print. Note that this is a different warning than the one for manufactured "cannabis products", which includes time-delay warning language: "GOVERNMENT WARNING: THIS PACKAGE CONTAINS CANNABIS, A SCHEDULE I CONTROLLED SUBSTANCE. KEEP OUT OF REACH OF CHILDREN AND ANIMALS. CANNABIS MAY ONLY BE POSSESSED OR CONSUMED BY PERSONS 21 YEARS OF AGE OR OLDER UNLESS THE PERSON IS A QUALIFIED PATIENT. CANNABIS USE WHILE PREGNANT OR BREASTFEEDING MAY BE HARMFUL. CONSUMPTION OF CANNABIS IMPAIRS YOUR ABILITY TO DRIVE AND OPERATE MACHINERY. PLEASE USE EXTREME CAUTION."

Cannabinoid Content: Percentage of Total THC and CBD on either the Primary or Informational Panel. Prop 65 Warning and Symbol: Use the short form "cancer and reproductive harm" warning. Any

The word "WARNING" must be bold and in caps. Minimum font size is 6 pt.

Cannabinoid Content: Percentage of THC and CBD on either the Primary or Informational Panel.

Prop 65 Warning and Symbol: Use the short form "cancer and reproductive harm warning. Any contrasting color is OK for the text of the warning except the word WARNING, which must be printed black, bold and in caps, and the symbol, bold and in black with either a yellow or white interior for the triangle. Minimum font size is 6 pt.
