PACKAGING

All product packaging and exit packaging must be pre-approved for use by the Oregon Liquor Control Commission (OLCC). For specifics, see the Guide.

Marijuana and hemp items cannot be packaged in a manner that may be "attractive to minors".

CR packaging is required for all marijuana and hemp items, except plants and seeds. Marijuana or hemp items can either be packaged in a CR container or placed into a CR exit package at the point of sale.

CR packages come in two forms, single-use and resealable (continually child-resistant). Note that violation of the CR packaging requirements carries a possible \$500 daily fine. CR packaging is not required for seeds and immature plants.

The Oregon Liquor Control Commission (OLCC) previously approved primary and exit packaging is listed online.

LABELING

Minimum font size is 1/16th of an inch

An item that contains both industrial hemp and marijuana must identify the item as a marijuana item.

A label may not:

- 1. Contain untruthful or misleading statements;
- 2. Be attractive to minors;
- 3. Specifically encourage the transportation of marijuana items across state lines;
- 4. Assert that marijuana items are safe because they are regulated or tested or make claims that any government agency endorses or supports marijuana;
- 5. Make claims of curative or therapeutic effects;
- 6. Depict consumption of marijuana;
- 7. Contain material that encourages the use of marijuana because of its intoxicating effect or that encourages excessive or rapid consumption.

PRINCIPAL DISPLAY PANEL

Three items are required, all visible at the same time:

- 1. Product identity (common name, not brand name) in bold type, reasonably related in size to the most prominent printed matter on the panel, and parallel with the package base;
- 2. Universal or hemp symbol at least .48" wide by .35" tall; and
- 3. Net weight or net volume in bold type, in the bottom 30 % of the panel, parallel with the base, and in both US Customary Units and in grams/milligrams or liters/milliliters.

SMALL CONTAINERS: There are optional labeling requirements for "small containers" and for "tiny containers", but inserts are not allowed.

VAPE CARTRIDGES: The universal symbol must be printed directly on a vape cartridge or attached as a sticker.

INDUSTRIAL HEMP:

- 1. Use the hemp symbol rather than the universal symbol.
- 2. Use this warning in place of those specified for marijuana: "This product is derived from hemp and could contain THC. Keep out of reach of children."
- 3. Use the warning: "DO NOT EAT " in bold capital letters for hemp products that are not edibles, tinctures or capsules.
